**Public Liability Insurance:** The Participant must hold a current public liability insurance policy applicable to the activity involved.

**Special Needs:** The Organising Committee will not be held responsible for special requirements but will do its best (when given adequate notice) to meet the needs of participants.

**Risk Assessment:** The Participant shall be responsible for managing all risks occurring from their activity and must abide by any direction given by the Organising Committee and/or relevant statutory authorities in relation to risk management.

**Allocated Area:** The Participant must trade/perform only within the site allocated and sites will not be altered in size on the day.

The display/stall equipment must be set up and removed in a safe manner and comply with safety standards.

**Indemnity:** The Participant agrees to indemnify the Agricultural Pastoral & Show Society of Lockhart Inc, the Organising Committee and its members and Lockhart Shire Council against all liability, claims, demands, expenses, fees, fines, penalties, suits, proceedings and any actions of any kind.

**Liability:** The Participant occupies and utilises the allocated site/space at their own risk, and releases the Agricultural Pastoral & Show Society of Lockhart Inc, the Organising Committee and Lockhart Shire Council from any liability for any damage to the display/stall or any property of any description or for loss of income due to event cancellation, adverse weather conditions or eviction due to non-coherence to safety regulations or terms of this agreement.
